ARISE-PMDA Joint symposium for Asian Clinical Trial

National Center for Global Health and Medicine (NCGM) and Pharmaceuticals and Medical Devices Agency (PMDA) will hold the "ARISE-PMDA Joint symposium for Asian Clinical Trial "How to promote clinical trials in Asia to enable early patient access to pharmaceutical products" from 15:00 to 18:00 on Tuesday, July 12.



Since 2020, NCGM has been supported by the "Project for Establishment of Network of Clinical Research and Clinical Trials in Asia" of the Japan Agency for Medical Research and Development (AMED). Furthermore, NCGM has established [the ARO Alliance for ASEAN and East Asia \(hereinafter ARISE\)](#) to promote global clinical trials in Asia and launched ARISE in December 2021. Cooperation with regulatory authorities as well as academia in each country is essential to conduct high-quality multi-regional clinical trials in compliance with regulations in Asia and accelerate regulatory approvals. Therefore, this symposium will be held jointly with PMDA, promoting regulatory harmonization in Asia.



In the first session, NCGM will introduce the role of ARISE in promoting clinical trials in Asia.

In the second session, presentations will be given on "Promotion of Good Clinical Practice (GCP) in Asia," including presentations on initiatives by regulatory authorities in Asia and expectations of Japanese pharmaceutical companies.

In the third session, under the theme of "How to combat COVID-19," presentations will be given on initiatives for early patient access to COVID-19 pharmaceuticals by industry, government, and academia, followed by a panel discussion among Japanese and Asian experts in various fields.

This symposium will be a valuable opportunity to understand the main points of each country's pharmaceutical regulations to promote clinical trials in Asia and discuss early patient access to COVID-19 vaccines and therapeutics.
